

NALA LOCAL MUNICIPALITY BID NOTICE AND INVITATION BID No 07/2012 and 08/2012

DESCRIPTION: APPOINTMENT OF CONSTRUCTION COMPANIES FOR REFURBISHMENT OF 11KV MAIN SUBSTATION IN BOTHAVILLE AND ASSOCIATED WORKS IN WESSELSBRON MV SUBSTATIONS

Tenders are hereby invited for the Supply, Installation and Commissioning of the 11kV Switchgear at Bothaville Main Substation and associated works in Wesselsbron in the Nala Local Municipal region. Tenderers should have a CIDB contractor grading of 5EP or higher. The contract comprises mainly of the replacement of 11kV Circuit Breakers and CT's.

Tender documents will be obtainable from the 4th May 2012, from the municipality against payment of a non-refundable tender amount of R500.00. Only bank guaranteed cheques or cash will be accepted. Cheques shall be made payable to the Nala Local Municipality. Duly completed tender enclosed in a sealed envelope marked "TENDER NO. Bid 07/2012:

Bothaville Main 11kV SUBSTATION: UPGRADING OF SWITCHGEAR with the name of the Tenderer, shall be deposited in the tender box provided at the Nala Local Municipality tender office, in Bothaville, before 12H00 on the closing date.

The tenders will be opened in public.

A compulsory clarification meeting with representatives of the Employer will take place at the Municipal Auditorium at municipal offices, at number 8 Preller, in Bothaville, on the 18th May 2012 starting at 10H00 hrs. Contract documentation will not be available on site, and the Engineer will not be available for inspection purposes on any other occasion. The closing date will be the 1st June 2012.

Contractors who have the following are eligible to tender and must provide such proof:

- Original Valid Tax Clearance Certificate
- Company Registration Certificate
- CIDB Registration Certificate 5EP or higher
- Original Valid B-BBEE Status Level Verification Certificate. (0 Points if not submitted)

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Nala Local Municipality where 90 points will be allocated in respect of price and 10 points in respect of B-BBEE.

Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state,
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state.

The Municipality does not bind itself to accept the lowest or any tender.
