PROPOSED BY-LAWS RELATING TO STANDARD CONTROL OF STREET VENDORS, PEDDLERS OR HAWKERS, STANDARD DUMPING AND LITTERING, STANDARD ELECTRICITY SUPPLY, STANDARD INDIGENT SUPPORT, STREET TRADING.
